In case of poisoning bleeding disorders and increased bleeding tendency my occur.

In severe poisoning a strong internal bleeding can cause circulatory collapse and consequent death.

Symptoms may be delayed in onset by days.

#### 4.3. Indication of any immediate medical attention and special treatment needed

In case of bleeding or reduced activity of prothrombin is indicated to use antidote vitamin K1 (phytomenadione) at a dose of 10-20 mg (5-10 mg in children) slowly iv or as an infusion. Further treatment: Vitamin K1 (phytomenadione) is administered to 6x daily at a dose of 10 mg iv depending on the clinical picture, in most serious poisonings to 125mg / day. Vitamin K3 (menadione) is not effective! Because of the risk of hematoma avoid intramuscular injections. In the case of severe bleeding blood transfusions and further substitution of coagulation factors in the form of fresh frozen plasma or prothrombin complex concentrate are also needed.
